Likewise, and in order to safeguard the safety and harmonious relations among my child or ward, his/her classmates and members of the educational community, I hereby give my consent for Senior Management and/or Academic Staff to carry out periodic and/or random inspections to the contents that my child or ward may bring to school, either in a backpack, suitcase or in any container in his/her possession, including the ones inside the locker or cubbyhole assigned. The above mentioned shall always be done in the presence of my child or ward, and at least 2 school employees.

If my child or ward is in 7th to 12th grade, I also authorize medical tests for the use of narcotics, prohibited drugs or controlled use (drugs test), as well as blood alcohol concentration tests if necessary, as indicated in the Code of Conduct, bearing the consequences that it establishes.
